### **Application Period:**

### **Application Procedure:**

- The online application form (<a href="https://cloud.itsc.cuhk.edu.hk/webform/view.php?id=13654720">https://cloud.itsc.cuhk.edu.hk/webform/view.php?id=13654720</a>) will be available during application period.
- An acknowledgement email will be sent to your CUHK (and personal) email address after the online form is submitted.

### **Required Documents for Application:**

- 1. Submit the following documents in ONE PDF in sequence via online application platform during application period:
  - **a.** A one-page curriculum vitae.
  - **b.** Application statement (maximum 300 words).
  - c. A copy of university academic report (unofficial transcript up to 2022/23 Term 2).
  - d. Screenshot of updated cumulative GPA.
  - e. Public examination certificate(s) such as HKDSE, National Higher Education Entrance Examination(普通高等學校招生全國統一考试), Joint Entrance Examination for Universities in PRC(普通高等學校聯合招生考试), GSAT(大學學科能力測驗), IB Diploma, GCE/ International A-Level, GCSE / IGCSE / GCE (O-Level), ACT / AP / SAT
- 2. Submit a copy of Term 2 academic report and screenshot of cumulative GPA via online application system in early June 2023.

#### **Interviews:**

Shortlisted applicants will be informed via email or phone call by 28 February 2023, and interviews will be arranged during 3 - 11 March 2023 (Reading Week).

#### **Results:**

Application results will be announced in June 2023.

## **Points to Note:**

- 1. Interview qualification:  $GPA \ge 3.0$  and application documents.
- 2. Admission prerequisites: good grades in at least 9 units from the following courses:

DSME1030 (or ECON2011), DSME1040 (or ECON2021), MATH1010/1018 (or MATH1510), MATH1030/1038 (or ENGG1120 or ESTR1005), CSCI1510/1520/1530/1540/1580 (or ENGG1110 or ESTR1002 or equivalence).

**Remark:** Other "equivalent" courses may be considered with discretion, including FINA2310 for non-business students, but DSME1035 and ECON1010 will not be accepted as a substitute for DSME1030.

- 3. Only applicants in Year 1 will be considered. Others will be considered on a case-by-case basis.

We reserve the right to request your assessment results for verification if needed. If it is not stated on Blackboard or any other platform, please request the teacher(s) to confirm your results via email, by stating your scores/grades, maximum scores/grades, mean, SD, class size, etc.
